## 1. Rules

The Regatta will be governed by the rules as defined in the *Racing Rules of Sailing and the Sail Canada Prescriptions 2017-2020*.

This is a double – handed race consisting of a Female (Helm/Captain) and a Male (Crew).

## 2. Eligibility

The Regatta is open to all sailors who hold a valid membership in EYC or SBYC.

## 3. Fees

\$10.00 per boat.

All fees are payable by cash or cheque to the Edmonton Yacht Club. Sorry no credit or debit payments will be accepted.

## 4. Awards

Awards will be presented to the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place finishers.

## 5. Schedule

Number of races: up to 3 races with no race starting after 2pm

## 6. Course

The course length and description will be advised at the Skippers Meeting.

## 7. Classes

All cruisers registered by 09:30 on race day will constitute a class.

## 8. **Scoring**

All races held this day constitutes the series.

## 9. **Radio Communications**

Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communications that is not available to all boats.

The Race Officer may communicate with the race fleet on channel 72.

## 10. **Disclaimer of Liability**

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.

## 11. **Insurance**

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$1,000,000.00 per incident or the equivalent.

## 12. **Rights to Use Name and Likeness**

In participating in this event, a competitor automatically grants the *Organizing Authority* and the sponsors the right in perpetuity, to make, use or show, from time to time and at their discretion, any motion pictures, still pictures and live taped or film television and other reproductions of him/her during the period of the competition for the said event in which the competitor participates and in all material related to the said event without compensation.
