## 1. Rules

The Regatta will be governed by the rules as defined in the *Racing Rules of Sailing and the Sail Canada Prescriptions 2021-2024*

## 2. Eligibility

The Regatta is open to all female sailors who hold a valid membership in the Sunshine Bay or Edmonton Yacht Clubs

## 3. Fees

\$10.00 per boat with early registration (by Friday before Race Day)

\$25.00 per boat up to 9:25am day of Race

All fees are payable by cash or cheque to the Edmonton Yacht Club.

The Race Committee reserves the right to cancel or postpone the race if sufficient boats are not pre-registered

Awards will be presented to the 1<sup>st</sup> place finishers.

## 5. Schedule

## 6. Course

## 7. Classes

All cruisers registered by 09:30 on race day will constitute a class.

**8. Scoring**

One race constitutes the series.

**9. Radio Communications**

Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communications that is not available to all boats. The Race Officer may communicate with the race fleet on channel 72.

**10. Disclaimer of Liability**

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.

**11. Insurance**

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$1,000,000.00 per incident or the equivalent.

**12. Rights to Use Name and Likeness**

In participating in this event, a competitor automatically grants the *Organizing Authority* and the sponsors the right in perpetuity, to make, use or show, from time to time and at their discretion, any motion pictures, still pictures and live taped or film television and other reproductions of him/her during the period of the competition for the said event in which the competitor participates and in all material related to the said event without compensation.
