

# Notice of Race

## FALL SERIES 2015

### 1. Venue

The Fall Series organized by the Sunshine Bay Yacht Club (SBYC) will be held on the west end of Lake Wabamun- approx. 80 km west of Edmonton near Seba Beach, Alberta.

### 2. Rules

The regatta will be governed by the rules as defined in the Racing Rules of Sailing.

### 3. Eligibility

Entry is open to all sailors who hold valid Membership of an ASA/CYA affiliated club. It's an insurance issue. If you are not currently a member of a sailing club, you may purchase a weekend membership for \$20.00 from EYC who graciously offers this service. Payment by cash or cheque only. Sorry no Visa or Interac. Cheques must be made payable to Sunshine Bay Yacht Club.

### 4. Classes

All cruisers registered before 10:30 am Sunday, August 30, 2015 will constitute a class. Efforts will be made to run at least three races each consecutive Sunday for four weeks. No race will commence after 3:00 pm each day.

### 5. Scoring

- 5.1 One race must be completed to constitute a series.
- 5.2 When fewer than 5 races are completed a boats series score will be the total of her race scores.
- 5.3 When 5-8 races are completed a boats series score will be the total of her race scores excluding her worst score.
- 5.4 When 9 or more races are completed a boats series score will be the total of her race scores excluding her two worst scores.
- 5.5 Scoring will be based on PHRF Time on Time (TOT) ratings as determined by SBYC rating committee.

### 6. Entry Fee

Cruisers \$ 30.00

### 7. Sailing Instructions

Will be available upon completion of registration at Sunshine Bay Yacht Club. Please print/complete the Registration Form below and bring it with you.

### 8. Course

Cruiser course will be a sausage course.

### 9. Disclaimer of Liability

Competitors participate in this regatta at their own risk, see rule 4. Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.

### 10. Insurance

Insurance is the responsibility of all participants.

### 11. Radio Communication

Boats will not send or receive radio transmissions while racing that is not available to all boats. This restriction application includes cellular phones. Race management will communicate with the race fleet on channel 9.

### 12. Awards

Prizes will be awarded to the top finishers in all classes. Prizes will be award as follows:

2-5 boats-	1 <sup>st</sup> Place
6-9 boats-	1 <sup>st</sup> & 2 <sup>nd</sup> Place
10 or more boats-	1 <sup>st</sup> , 2 <sup>nd</sup> & 3 <sup>rd</sup> Place

**13. Rights to use name and likeness**

In participating in this event, a competitor automatically grants the Organizing authority and the sponsors the right in perpetuity, to make, use or show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of the competition for the said event in which the competitor participates and in all material related to the said event without compensation.
